REBUILDING UKRAINE: THE IMPERATIVE OF UNITED HUMANITARIAN SPACE IN THE CONTEXT OF EUROPEAN INTEGRATION

Abstract. The article examines the key role of the united humanitarian space of Ukraine in the context of European integration, in particular after the full-scale invasion of Russia. The successes and challenges of Ukraine in accordance with EU standards are considered, the urgent need for stabilization and reconstruction of a single humanitarian corps is emphasized. The article emphasizes the need to restore infrastructure, restore public services, and restore the economy, and calls for governance mechanisms and international support. effective Through comprehensive analysis and policy recommendations, the article examines geopolitical dynamics, reconstruction frameworks, stakeholder coordination, and the importance of international solidarity and funding on Ukraine's path to stability and development.

The article identifies that Ukraine's desire for closer ties with the European Union (EU) through its European integration efforts marks an important milestone, highlighted by its desire to align policies and standards with those of EU member states. However, this attempt creates enormous challenges, in particular, reforming Ukraine's humanitarian space in accordance with EU standards. Internal and external centrifugal forces threaten unity in this space, exacerbated by political instability, regional differences and vested interests of the parties. The implementation of strategic policies, including open dialogue and democratic reforms, is critical to mitigating these challenges and strengthening unity.

It was analyzed that both Ukraine and the EU should initiate institutional reforms to achieve harmonious integration. Strengthening administrative efficiency, improving the management structure and ensuring transparency is a real result for facilitating this process and strengthening unity in the humanitarian space of Ukraine. It has been proven that the construction of a united humanitarian space of Ukraine is necessary, especially after the Russian invasion, which caused significant damage to infrastructure, displaced persons and destabilized the economy. Stabilization and reconstruction efforts are paramount to restoring normalcy and ensuring long-term development.

ВІДНОВЛЕННЯ УКРАЇНИ: ІМПЕРАТИВ ЄДИНОГО ГУМАНІТАРНОГО ПРОСТОРУ В КОНТЕКСТІ ЄВРОПЕЙСЬКОЇ ІНТЕГРАЦІЇ

As noted by Moisiyakha A.V. researching the algorithm of formation and application of mechanisms for the implementation of state policy in the socio-humanitarian sphere, state policy in the socio-humanitarian sphere is distinguished by its complexity, interdependence of various mechanisms and tools, as well as a high level of institutional saturation of the public sector in the implementation of the main directions and solving the key tasks of the specified type of state policy. Institutional saturation determines the

Chukut, etc.) who in their works highlighted the trends and others the state of development of the humanitarian sphere of Ukrainian society as a target social activity, the conceptual vision of the state humanitarian policy and the mechanisms of its implementation. A certain contribution to the research of the public administration aspect of the functioning and development of the humanitarian sphere was made by scientists in the field of public administration. However, it should be noted that researchers mostly pay attention to the development of its individual segments. Thus, S. Andreychuk, M. Bilinska, V. Gamayunov, T. Hladka, V. Grabovskyi, S. Gryganska, etc. consider the versatile aspects of the state education management system in their dissertations. The question of the role of prioritized areas and strategies crucial for Ukraine's stabilization and reconstruction in the humanitarian space, especially in the conditions of European integration, has not been studied in sufficient detail, and therefore there is a need to analyze this issue.


